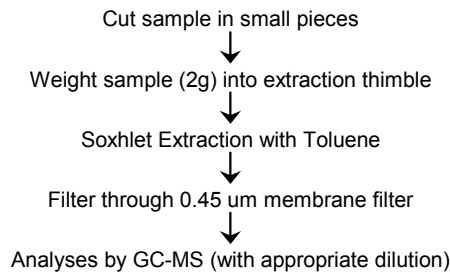
1. DETERMINATION OF HEXAVALENT CHROMIUM BY METHOD US EPA 3060A/7196A



2. MICROWAVE ASSISTED ACID DIGESTION OF ORGANICALLY BASED METRICES (US EPA 3051A)




3. DETERMINATION OF PBB/PBDE WITH GC-MS
